WASHINGTON COUNTY (Owner) is requesting Bids for the construction of the following Project(s):

- ITB 2023-01: Creek Road, Douglas Ferry Road (3 locations), Old Bonifay Road and Clayton Road, Contract Time of 90 days

Sealed Bids for the construction of the Project(s) will be received by the **Washington County Board of County Commissioners** at **1331 South Blvd, Chipley, Florida 32428** until **3:30 PM** local time on **Tuesday, February 7, 2023**, at which time the Bids received will be **“publicly”** opened and read. The sealed bid submittal shall include 1 original, 2 copies, and one electronic copy on USB flash drive.

The Project(s) includes the following Work:

This project consists of clipping 2” of the existing base, constructing 2” of asphalt, construction of cast in place (CIP) headwalls, sod and sediment barrier at the following locations:

Location 1 – Creek Road west of SR 79: 104’ long by 20’ wide, two double 30” headwalls

Location 2 – Douglas Ferry Road east of SR 79: 25’ long by 20’ wide, two single 30” headwalls

Location 3 – Douglas Ferry Road east of SR 79: 30’ long by 20’ wide, two double 30” headwalls

Location 4 – Douglas Ferry Road east of SR 79: 37’ long by 20’ wide, two double 30” headwalls

Location 5 – Old Bonifay Road east of Riley Lane: 28’ long by 22’ wide, no headwalls

Location 6 – Clayton Road east at Falling Waters Road: 37’ long by 20’ wide, no headwalls

All construction shall be in accordance with the FDOT July 2022 Standard Specifications for Road and Bridge Construction and the FDOT 2023-24 Standard Plans.
