The Washington County Board of County Commissioners is currently accepting applications for a **HEAVY EQUIPMENT OPERATOR III** position. The primary function of the Heavy Equipment Operator III will be to operate machinery in connection with the construction, repair and maintenance of roads and right-of-ways within Washington County. An employee allocated to this position must be able to operate various types of heavy equipment to cover absences or provide relief to equalize peak work periods, or otherwise balance the work load.
